TERM & CONDITIONS

1. Participation Fee & Cancellation

Upon submission of the registration form to the Organiser, the Exhibitor agrees to make a 50% payment within seven (7) days upon receipt of the invoice. The remaining 50% balance must be paid one (1) month before the event. If payment is not received, the Organiser is entitled to cancel the booking made by the Exhibitor. Any cancellation made within thirty (30) days before the event will result in forfeiture of all exhibitor fees. Non-payment or non-attendance does not constitute cancellation and shall not entitle the Exhibitor to any refund. If the Organiser cancels or postpones the exhibition, the Organiser will not be responsible for any Exhibitor costs incurred. Any exhibition fee already paid will not be refunded but may be credited to a future exhibition of the same value, subject to the Organiser's discretion. The event programme is subject to change without notice. A penalty of five percent (5%) of the total invoice amount will apply for non-payment. A penalty of three percent (3%) of the total overdue amount will apply for late payment.

2. Allocation of Booth & Set Up

Booth allocation is at the absolute discretion of the Organiser, in accordance with the nature of exhibits and in any manner deemed fit and appropriate, including HSSC compliance. If the Exhibitor engages a contractor other than the official contractor, approval must be obtained from the Organiser. The non-official contractor must comply with all Terms & Conditions herein.

3. Prohibitions

Exhibitors are prohibited from displaying anything unlawful, offensive, explosive, or immoral at their booth. The Organiser reserves the right to instruct the Exhibitor to remove such items immediately. If the Exhibitor fails to comply, the Organiser may remove the items and the Exhibitor shall be liable for all related costs and expenses. The Exhibitor shall not assign, sub-let, or allow any other party (including agents, manufacturers, employees, suppliers, or third parties) to occupy the booth without the Organiser's written consent. Exhibitors are not allowed to dismantle displays before the official closing time set by the Organiser.

4. Rights of Removal

The Organiser reserves the right to prevent access to, or remove from, the exhibition space (including the booth) any person(s) acting in a manner that may cause a breach of peace, be harmful, undesirable, offensive, or pose a danger to public safety, including the safety of those present.

5. Change of Venue and/or Time

The Organiser reserves the right to amend the venue and/or duration of the event and shall inform the Exhibitor accordingly. Such changes do not entitle the Exhibitor to cancel participation. The Exhibitor agrees that the Organiser shall not be liable for any claim arising from such change.
